Artists retain copyright to their work, the above agreed-to permissions notwithstanding.

- Save your image as a .jpg or .png and attach to an email
- Artwork should follow guidance of your school's rules for appropriateness and respectful of others
- Art previously published online or in print by a third party are not eligible. This includes print outlets and
  professional websites/social media accounts. Images you've shared on your own personal pages are still
  eligible.

**Submitting Audio:** Complete this form & the permission slip and email to <a href="mailto:susan.quincy@ct.gov">susan.quincy@ct.gov</a>. Then go to <a href="mailto:Flipgrid">Flipgrid</a> (code a6ca5f50) to record or upload your piece. Be sure to read the instructions carefully:

- Record your original piece directly to Flipgrid
- Make the recording without showing your face or an image of yourself. Use of backgrounds, local sites, outdoor recordings, or other visuals to accompany the recording are allowed
- Use appropriate language and be respectful of others
- You may record in an indoor or outdoor setting for the piece, but do not include other people in the recording
- Poetry, songs, and musical pieces previously published online or in print by a third party are not eligible. This
  includes print outlets and professional websites/social media accounts. Original works you've shared on
  your own personal pages are still eligible.
- Submissions and forms are due by 12:00 p.m. midnight, EST, March 26th 2021.
